**Mandate**

- The River Club will at any time after the commencement of your membership be able to increase the monthly contribution amount after providing a 1 months' notice period letter. The River Club cannot be held liable if the communication was not received by the member.
- I understand that should my monthly subscription not be received by The River Club, that all my membership benefits will be frozen until my account has been rectified.
- Monthly subscriptions are payable in advance.
- I agree to the River club debiting my nominated account for the monthly membership fees.
- I understand that neither my membership nor commensurate benefits are transferable.
